NABCB grants first accreditation for Business Continuity Management Systems (BCMS) Scheme

In the last few years, COVID-19 pandemic has made organizations aware of the importance of Business Continuity Management. We all know that sometimes such events cannot be avoided, but at the same time it is possible to be prepared, minimize the impact, and restore the operations in a minimum time. As a result, organizations around the world are becoming more aware of the importance of Business Continuity. The Certification Bodies seeking accreditation for Business Continuity Management Systems Certification based on ISO 22301- Security and resilience — Business

continuity management systems — Requirements shall comply with the requirements specified in ISO/IEC 17021-1 - "Conformity assessment — Requirements for bodies providing audit and certification of management systems" and ISO/IEC TS 17021-6 – "Competence requirements for auditing and certification of business continuity management systems". NABCB is glad to announce that it has granted its first accreditation in Business Continuity Management System (BCMS) scheme to M/s Maverick Quality Advisory Services Pvt. Ltd., Ghaziabad.







NABCB updates the Accreditation Criteria for Accreditation of Validation and Verification Bodies as per ISO/IEC 17029:2019

IAF had passed a resolution in October 2019 which mandates that all accreditations against the new version of ISO 14065:2020 shall also require accreditation to ISO/IEC 17029:2019 Standard (Conformity assessment—General principles and requirements for validation and verification bodies), which is applicable to Validation/Verification Bodies across industry sectors. IAF has already endorsed the extension of its MLA to include ISO/IEC 17029 as Level 3 Standard for Validation & Verification.

In view of this, NABCB with the approval of Board had constituted a Technical Committee for Validation and

Verification Bodies to align the existing scheme for GHG Validation & Verification, and finalize the relevant documents (Accreditation Criteria & Accreditation Procedure, Application Form, Cross Reference Matrix) in line with requirements of ISO/IEC 17029:2019. The documents of the current GHG accreditation scheme have been aligned to introduce ISO/IEC 17029:2019 as accreditation criteria along with sector-specific criteria. In this effect, the realigned NABCB Validation & Verification Scheme was announced on the eve of 26 January 2022. The latest documents are available on NABCB website.

NABCB and NBQP jointly organized Virtual Quality Conclave on "Emerging Scenario in Food Safety & Quality"

NABCB along with other constituent board of QCI, National Board for Quality Promotion (NBQP) jointly organized the 20th Virtual Quality Conclave (VQC) with the theme "Emerging Scenario in Food Safety & Quality" on 8 March 2022. The primary objective of the Conclave was to provide a platform for key stakeholders to discuss and share the emerging technology, innovations and best practices adopted by the regulators, industry, and service sector in these ever-changing circumstances in the food industry. The conclave commenced with the welcome address by Mr. Rajesh Maheshwari, CEO, NABCB. The Key Address was delivered by Ms. Inoshi Sharma, IRS, Executive Director, FSSAI. Speaking on the occasion, she talked about the significance of technology in today's food industry as food processing, storage, transportation, packaging, durability depends on the technology used by the industry.


The Inaugural session was followed by two technical sessions. The first technical session was on "Regulatory and Accreditation landscape in Food Industry". The session was moderated by Dr. Ramanand N. Shukla,

Director, ZED, QCI and the speakers were Mr. Sunil Bakshi, Head (Regulations/ Codex), FSSAI; Mr. H.J.S Pasricha, Scientist-F&DDG (Certification & CSMD), BIS; Mr. Tarun Bajaj, Director, APEDA; Ms. Varsha Mishra, Deputy Director, NABCB. The speakers informed about various regulations in the Food Sector and the role of accreditation in achieving quality & regulatory compliances in the food sector.

The second technical session was on Emerginsg Technologies and Practices in Food Industry. The session was moderated by Dr A. Raj, Senior Director, ZED, QCI and the speakers were Dr. K.S Murty, Head of Science and Business & Head Scientific Services, ITC Ltd; Mr. Govindarajan VS, DGM & Head Quality, Adani Wilmar Ltd; Mr Shailendra Kumar, DGM Corporate Quality Assurance, Mother Dairy Fruit & Vegetable Pvt. Ltd.; Mr Prabodh S. Halde, Head Regulatory, Marico Ltd. and Ms Prethika M, Analyst, PADD. In this session insights on the emerging technology trends and best practices adopted by Industry in Food Safety and Quality were discussed.



The conclave targeted the representatives from food manufacturing sectors, process owners, quality & technical managers, representatives of federations, associations, govt & non-govt organisations, procurement & supplier, consumers etc. The Conclave received a positive response. Approx. 445 participants attended the event.



NABCB conducts Virtual Annual Inspection / Validation & Verification Bodies Meeting

NABCB annual applicant & accredited Inspection Bodies (IBs) and Validation & Verification Bodies meeting was held virtually on 15 March 2022 and was attended by representatives from Inspection Bodies (IBs) and Validation and Verification Bodies (VVBs). NABCB conducts the annual meeting to discuss the issues faced by IBs/VVBs and update them on new developments. The meeting was attended by 100+participants.

Mr. Rajesh Maheshwari, CEO, NABCB delivered the welcome address wherein he explained to the participants the purpose of the annual meeting. He highlighted various initiatives taken by NABCB in growing the inspection business. He further discussed about various regulators who are relying on NABCB Accredited Bodies.

The high points of the meeting were the active participation of officials of different Regulators / Government bodies and Industries utilizing the services of accredited Inspection Bodies shared their requirements and experiences. The government organisations and regulators of India such as Bureau of Indian Standards (BIS), Petroleum and Natural Gas Regulatory Board (PNGRB), Directorate General of Civil Aviation (DGCA) were invited to share their experiences and updates. Representatives from these organisations discussed the importance of accredited third-party Inspection Bodies in various regulations and the expectations they have from the accredited Inspection Bodies.


Representative from Industry i.e. GAIL (India) Limited,

Further in the meeting had technical sessions wherein updates were provided on WA requirements, scope statements, NABCB portal and website, ILAC/MRA Mark and Unique Identification Number. The CABs were updated on new NABCB policy on extraordinary events and remote assessment which will be in effect from 1st April 2022. The VVBs were briefed on ISO/IEC 17029:2019 standard and changes in NABCB accreditation criteria and procedure for VVBs.

There was an Open House session wherein the queries/issues faced by Inspection bodies were discussed and resolved by NABCB secretariat.




NABCB conducts Virtual Certification Bodies Meeting




Three-Day Assessors Virtual Training Course on ISO/IEC 17021-1:2015 and ISO 17029:2019



Ms. Chang Kwei Fern, APAC Chair in her inaugural address sought feedback from members about the database. 45 APAC members participated in the webinar.








NABCB Participated in Joint Working Group Committee ILAC-IAF Communication Professionals meeting


Ms. Varsha Misra, Deputy Director, NABCB participated in JWGC ILAC - IAF meeting she has addressed the




NABCB Participated in IAF Food Working Group

NABCB attends PTB-APAC's SANAP Closing Event






Webinar on Overview of ISO/IEC 17065:2012 and ISO/IEC 17067:2013
