NABCB Celebrates World Accreditation Day 2023










World Accreditation Day 2023: Theme, History, and Significance



Preamble

National Accreditation Board for Certification Bodies (hereinafter "NABCB"), a constituent Board of Quality Council of India (QCI), and Automation Standards Compliance Institute (hereinafter "ASCI") hereby confirm their commitment to cooperate in current and future accreditation programs for ISASecure® industrial automation and control systems (IACS) cybersecurity certification scheme which currently includes the CSA (Component Device Security Assurance) certification, SSA (System Security Assurance) certification and, SDLA (Security Development Lifecycle Assurance) certification, hereinafter called the ISASecure Schemes.

NABCB's accreditation program shall be implemented in accordance with all relevant international standards, including International Standards Organization's ISO/IEC 17011 Conformity Assessment – General requirements for Accreditation Bodies accrediting conformity assessment bodies.

NABCB's accreditation program will assess the competence of Chartered Certification Bodies against the requirements of the international standard, ISO/IEC 17065 and rely on ISO/IEC 17025 accreditation (where applicable), and the additional requirements as specified in the ISASecure Scheme documents, such as CSA-200, SSA-200, SDLA-200. (If requested by NABCB, ASCI will specify the tables for NABCB to reduce the ambibuity of requirements and provide finite definition).

The two-day conference witnessed the launch of the National Medical Device Policy along with the launch of Medical Devices Export Promotion Council and others.






NABCB attended the 44th plenary of ISO COPOLCO

The workshop received overwhelming response with more than 70+ participants from NABCB Accredited CABs, NABCB Assessors, NABCB officials and other relevant stakeholders.




NABCB Monthly Webinars

Webinar on Accreditation of Management Systems Certification with a focus on Food Safety Management Systems (FSMS)


