NABCB Assessor Training Course on ISO/IEC 17029:2019 & ISO/IEC 17020:2012

NABCB undertook a strategic initiative aimed at expanding and enhancing its Assessor pool, while also providing training for its existing assessors and technical experts. This comprehensive effort involved conducting two distinct 3-day training courses: one focused on ISO/IEC 17029 and the other on ISO/IEC 17020:2012.

The training sessions took place on specific dates: the ISO/IEC 17029 training occurred from 10th to 12th Sept 2023, while the ISO/IEC 17020:2012 training was scheduled for 28th to 30th Sept 2023.

To ensure the effectiveness of these training courses, NABCB enlisted a team of seasoned professionals to serve as faculty members. For ISO/IEC 17029:2019, the faculty included Dr. S Ravi Shankar, Mr. B Venkatraman, and Dr. Kumar M Iyer, all of whom were esteemed technical experts in their respective fields. For ISO/IEC 17020:2012, Mr. S Krishnamurthy and Mr. R.D Khatri brought their substantial expertise to the training.

The training sessions were designed to be highly interactive, going beyond mere theoretical instruction. Participants received in-depth insights into the standards themselves, as well as a comprehensive understanding of relevant IAF Documents, NABCB Accreditation criteria, and procedural aspects. In an effort to foster a more holistic understanding, the experienced faculty members generously shared their real-world experiences and presented case studies. This approach was intended to stimulate critical thinking and encourage participants to adopt the mindset and skills required to excel as assessors.

To gauge the effectiveness of the training and assess the participants' grasp of the material, an evaluation component was incorporated into the program. This multifaceted approach not only expanded NABCB's Assessor pool but also enhanced the capabilities of existing assessors and technical experts, ultimately strengthening the organization's commitment to accreditation and quality assurance.

The inaugural session had the presence of dignitaries including Mr. Narendra Singh, Union Minister of Agriculture and Farmers' Welfare; Mr. Amitabh Kant, G20 Sherpa; Dr. Tedros Adhanom Ghebreyesus, Director General, WHO.

The summit had the august presence of Mr. Bedu Ram Bhushal, Minister of Agriculture & Livestock development, Govt. of Nepal. The Summit marked a significant step forward in promoting international cooperation, knowledge sharing and cross-learning to create a safer and more sustainable global food system. The shared commitment and expertise exhibited during the summit will undoubtedly drive positive change and safeguard the well-being of consumers worldwide.

The event witnessed the participation of food regulators from different countries including UK, Germany, Thailand, Brazil, Bhutan, Chile, Ethiopia, Mauritius, Mozambique, US, Canada, Italy and New Zealand.




NABCB attended the Introductory Webinar to PEFC ST 1004






NABCB attended APEDA Training Webinar

The conference was also attended by various luminaries from reputed government and public sector organizations.




NABCB Attended IAF DMC Webinar






NABCB Attended Annual ISO Meeting
