**Education Qualification:** Graduate in Engineering/Technology or Post Graduate in Science or any other relevant / Professional Qualifications or equivalent.

**Experience:** Applicants must have minimum of 10 years of extensive Industry work experience in relevant areas. Upper age limit is 62 yrs. Persons once selected for empanelment with NABCB have to disassociate from conformity assessment bodies, if any, in all aspects w.r.t. training, auditing, certification etc.

Prior auditing/inspection experience would be preferable. Applicants for Management Systems must have completed 5-days Lead auditor course (recognised course) on respective Management Systems standard(s).

**Selection Procedure:** Shortlisted Assessors and Technical experts will have to undergo training and evaluation by NABCB on relevant Accreditation Standards. Empanelment of Assessors & Technical Experts will be based after successful completion of NABCB training and evaluation.
