### 1. Backdrop:

While accrediting the Inspecting Bodies for ISO/IEC 17020 with respect to IAF Scope Sectors-26 (Natural Gas Pipeline or NGPL & City Gas Distribution or CGD, Liquefied Natural Gas or LNG), 31a (Petroleum & Petroleum Products pipelines or PPPL, LPG Bottling and Over-ground/Refrigerated/Underground and Cavern storage facilities, Petroleum Refineries and Gas Processing Plants, Petroleum Installations (PI)) and 34 (Emergency Response & Disaster Management Plan or ERDMP) with traceability to PNGRB's Technical T4S, IMS and ERDMP Regulations, it has been observed by NABCB that individual IBs are competent in one or more of following:

#### a) IAF Scope Sectors-26 and 31:

- **Stage-Wise inspection:** A Third Party Inspection during **various stages of Construction** from beginning till final commissioning, in field of City Gas Distribution (CGD) /Natural Gas Pipeline (NGPL) /Liquefied Natural Gas (LNG) / Liquefied Petroleum Gas (LPG) /Petroleum & Petroleum Products Pipeline (PPPL) /PI (Petroleum, Oil & Lubricants) /Petroleum Refineries & Gas Processing Plants (GPU) / LPG Recovery Unit (LRU) / Retail Outlet (RO).
- **In-service Audit:** A Third-Party Inspection during **Operation of facility**, involving T4S Audits & / or Integrity Management System (IMS) assessment, in CGD/NGPL/LNG/PPPL/LPG /PI/ Refineries & Gas Processing /LPG Recovery Unit / RO under Scope-26 and 31a.
- **Both Stage-Wise Construction inspection & In-service Audit**, specific or in combination, in CGD/NGPL/LNG/PPPL/LPG/PI/ Refineries & Gas Processing /LPG Recovery Unit/ RO.

#### b) IAF Scope Sector-34 (ERDMP):

- **In-service Inspection** for Verification of ERDMP in downstream areas (“a” to “i” as identified in ERDMP Regulations-2010 of PNGRB (in Singular / Combination/ Entire mid & downstream chain as mentioned in ERDMP Regulation-2010 of PNGRB with amendments if any till date)

### **Mandatory Aspects ( Use of term “ Shall) for Stage-wise Inspection :**

- i) Inspecting Body (IB) shall seek Stage-wise inspection accreditation from NABCB only if they intend to carry out Third Party Inspection (TPI) for Construction activities with traceability to concerned PNGRB Regulation or Quality Assurance Plan (QAP) derived by consensus between Client, Contractor and Third Party Inspection Agency (TPIA) prior to commencing Construction inspection.
- ii) The QAP so derived between Client, Contractor & Third Party Inspection Agency (TPIA) shall be traceable to concerned PNGRB Regulation (wherever traceability exists) and national & international Codes applicable to Stage-wise Construction inspection.
- iii) Any Material/Equipment inspection in Oil & Gas shall be considered by NABCB in respective IAF Scope(s) for Mechanical/ Electrical/ Instrumentation/ Civil items.
