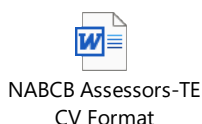
Education Qualification: Graduate in Engineering/Technology or Postgraduate in Science or any other relevant / Professional Qualifications or equivalent.

Experience: Applicants must have minimum 10 years of extensive work experience in industry / conformity assessment in relevant areas. Upper age limit is 62 yrs. Persons once selected for empanelment with NABCB have to dissociate himself/herself from Conformity assessment bodies, if any, in all aspects w.r.t. training, auditing, certification etc.

Prior experience in Carbon footprints, Greenhouse emissions, Life cycle assessments, Sustainability and related schemes such as Verra VCS, ICAO CORSIA, Gold Standard, GCC would be preferable.

Selection Procedure: Shortlisted Assessors and Technical experts will have to undergo training and evaluation by NABCB on relevant Accreditation Standards. Empanelment of Assessors & Technical Experts will be based after successfully undergoing NABCB training and evaluation.
