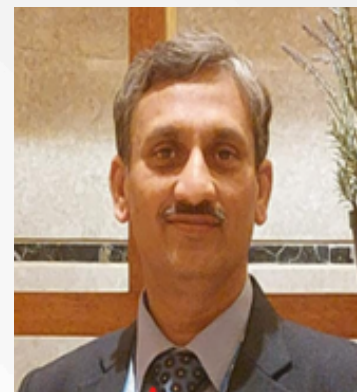

# GUIDANCE TO USE NABCB ACCREDITATION SYMBOL AND ILAC MRA MARK/ IAF MLA MARK

**BCB 202, Feb 2023 Specifies the Conditions for Use of NABCB Accreditation Symbol and other claims of accreditation, IAF MLA Mark and ILAC MRA Mark**

## **Design and Representation of Accreditation Symbols**

The NABCB Accreditation Symbol has been thoughtfully designed to reflect credibility, competence, and international alignment. It incorporates the NABCB Symbol along with the unique Accreditation number assigned to each accredited Conformity Assessment Body (CAB). The approved design specifications—including proportions, color schemes, and usage format—are provided in Appendix A for the NABCB Symbol and Appendix B for the combined NABCB–IAF MLA / ILAC MRA Mark.

Accredited CABs may also use the Combined IAF MLA Mark (for certification bodies and validation/verification bodies) and the ILAC MRA Mark (for inspection bodies), as permitted. Their use must follow the latest guidelines outlined in the IAF ML 2 and ILAC R7 documents, which govern global recognition marks under the Multilateral Mutual Recognition Arrangements. Use of these international marks requires a formal agreement between NABCB and each accredited CAB, ensuring proper representation and alignment with global Accreditation frameworks.

## **Conditions for Using NABCB Accreditation Symbol and International Accreditation Marks**

Accredited CABs are authorized to use the NABCB Accreditation Symbol and associated IAF MLA / ILAC MRA Marks strictly for the services and locations covered under their scope of accreditation. These symbols must:

- Not be used in a misleading manner, nor imply any product or service endorsement by NABCB.
- Not be placed on products, packaging, visiting cards, buildings, or vehicles, except when used in large-format advertisements where context is clear.
- Be used only in promotional materials that clearly distinguish accredited services from non-accredited offerings.



If accreditation is suspended or withdrawn, CABs are required to immediately discontinue the use of all NABCB and international marks across all media and communication channels.

### Use of Scheme Owner Marks

Where applicable, CABs may display scheme-owner logos—such as FSSC 22000, AYUSH, or NPOP—on certificates, provided the scheme-specific rules permit such use. These marks must always be presented correctly and must not overshadow or appear more prominent than the NABCB Accreditation Symbol. Proper alignment ensures consistency, credibility, and recognition across national and international certification landscapes.

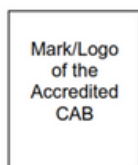

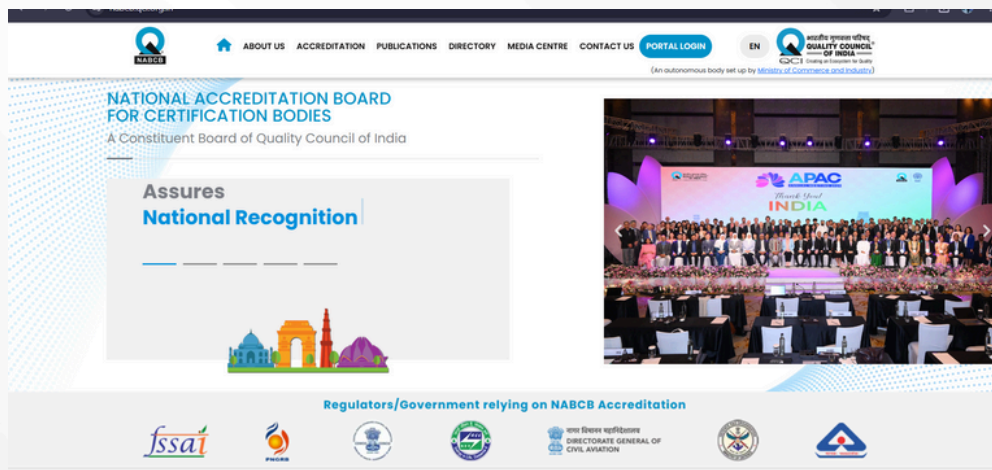
#### Mark/Logo for Accredited CAB combined with NABCB Accreditation Symbol

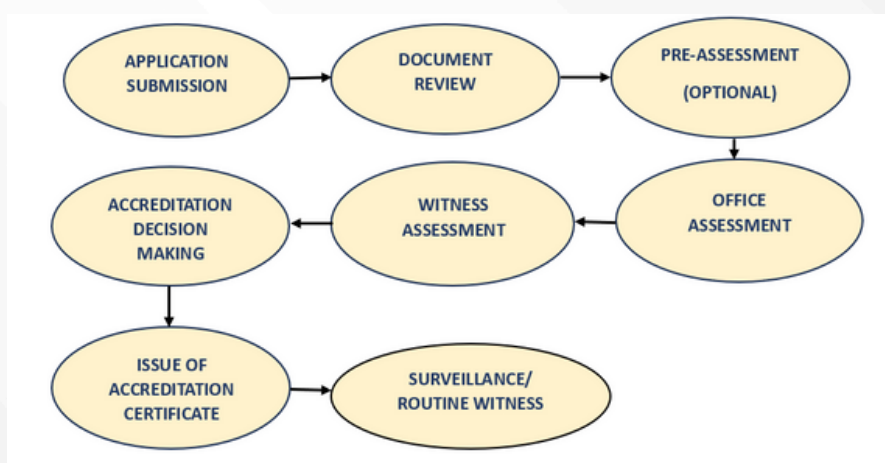

Flow chart of Accreditation Process

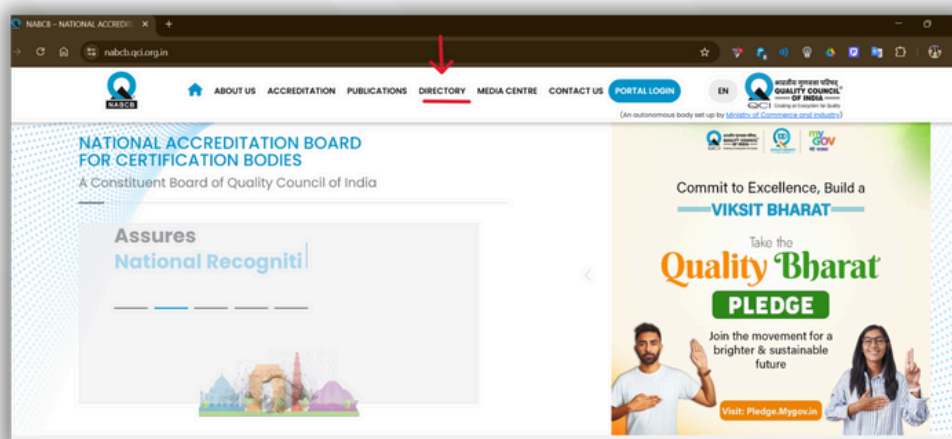

# INTER PSU GUNVATTA MANTHAN-2025

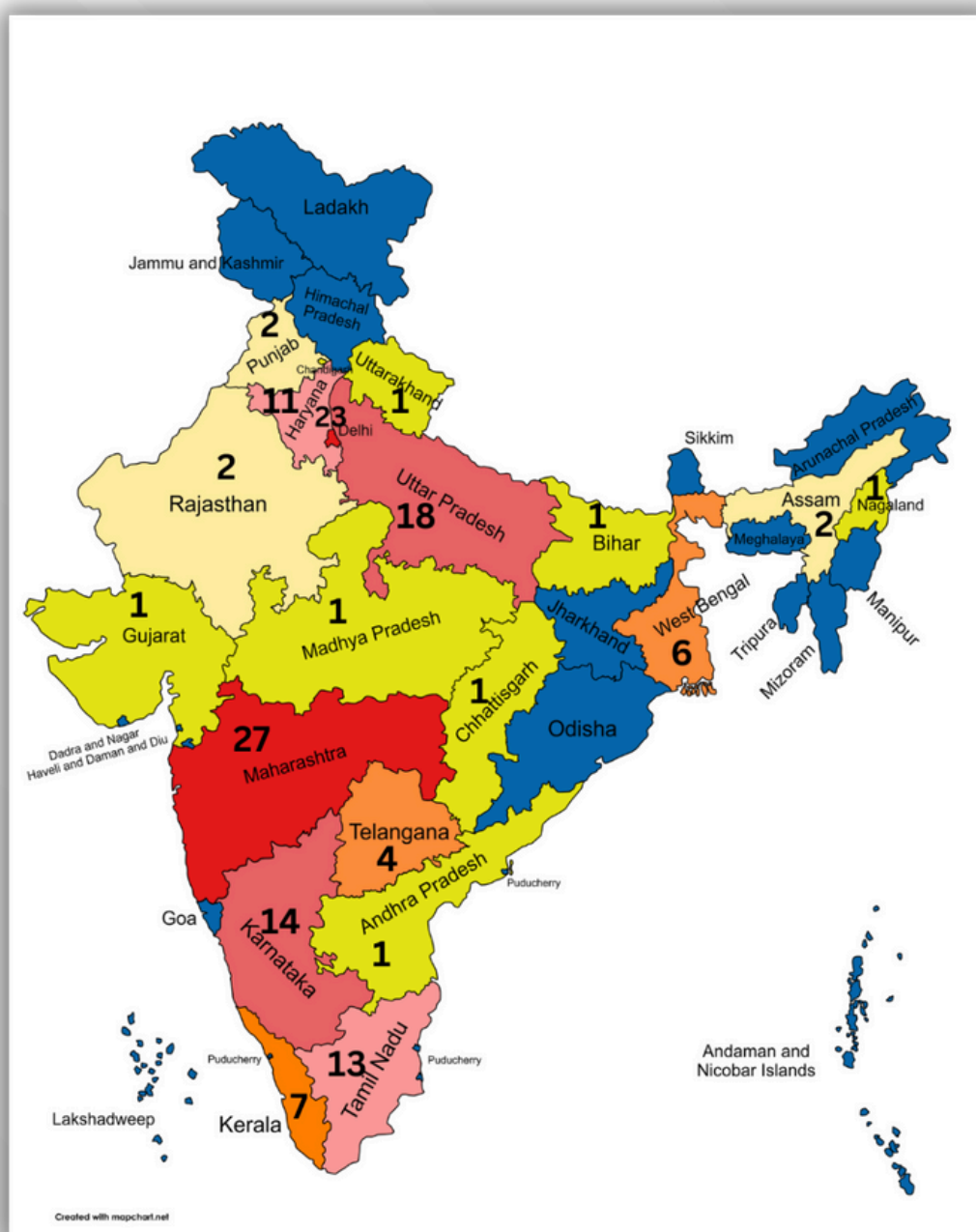

The map below illustrates the nationwide presence of NABCB-Accredited Certification Bodies (CBs) across India.

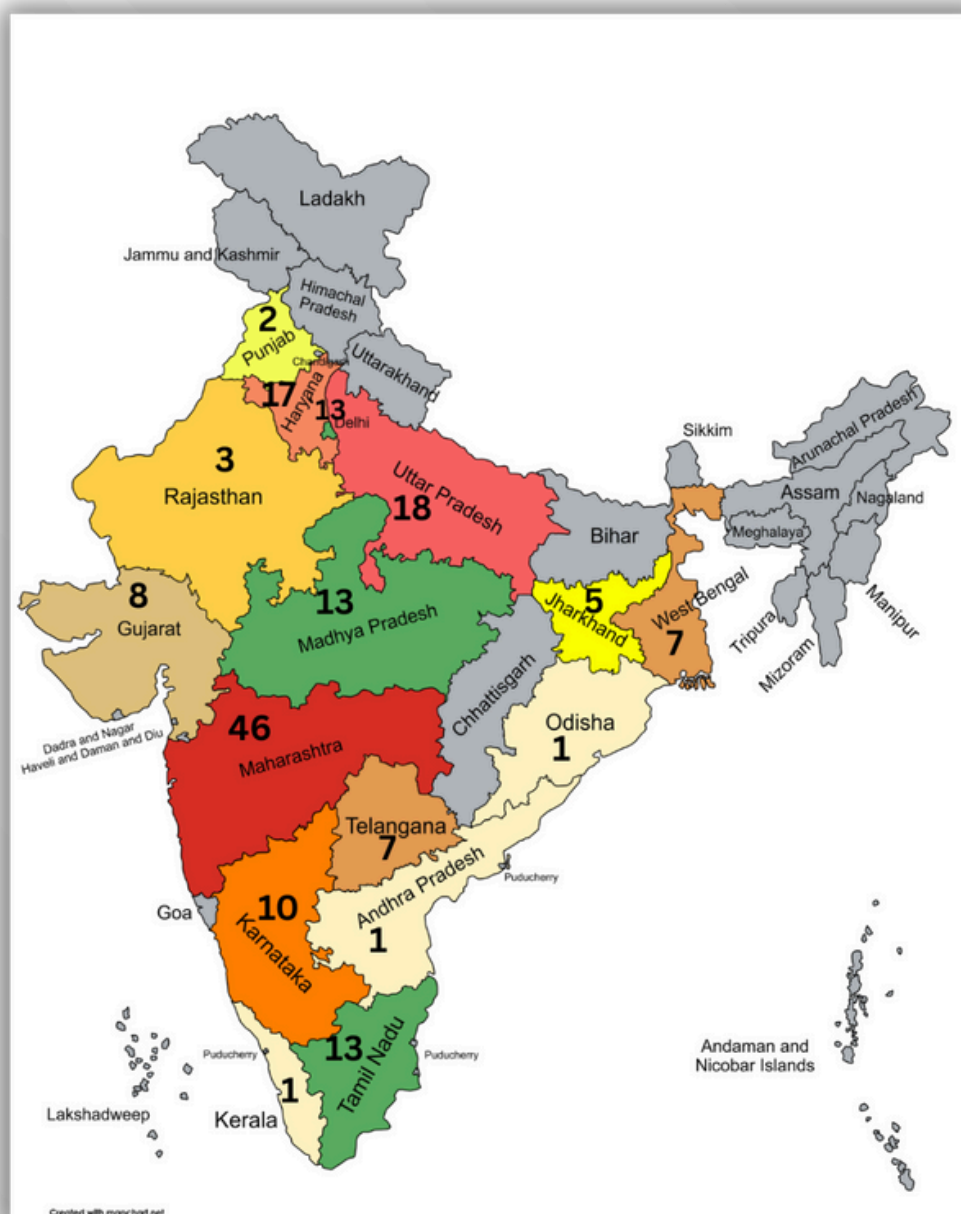


State-wise Accreditation of NABCB-Accredited Certification Bodies

The map below presents the state-wise presence of NABCB-Accredited Inspection Bodies (IBs) across India, highlighting their distribution and operational reach.



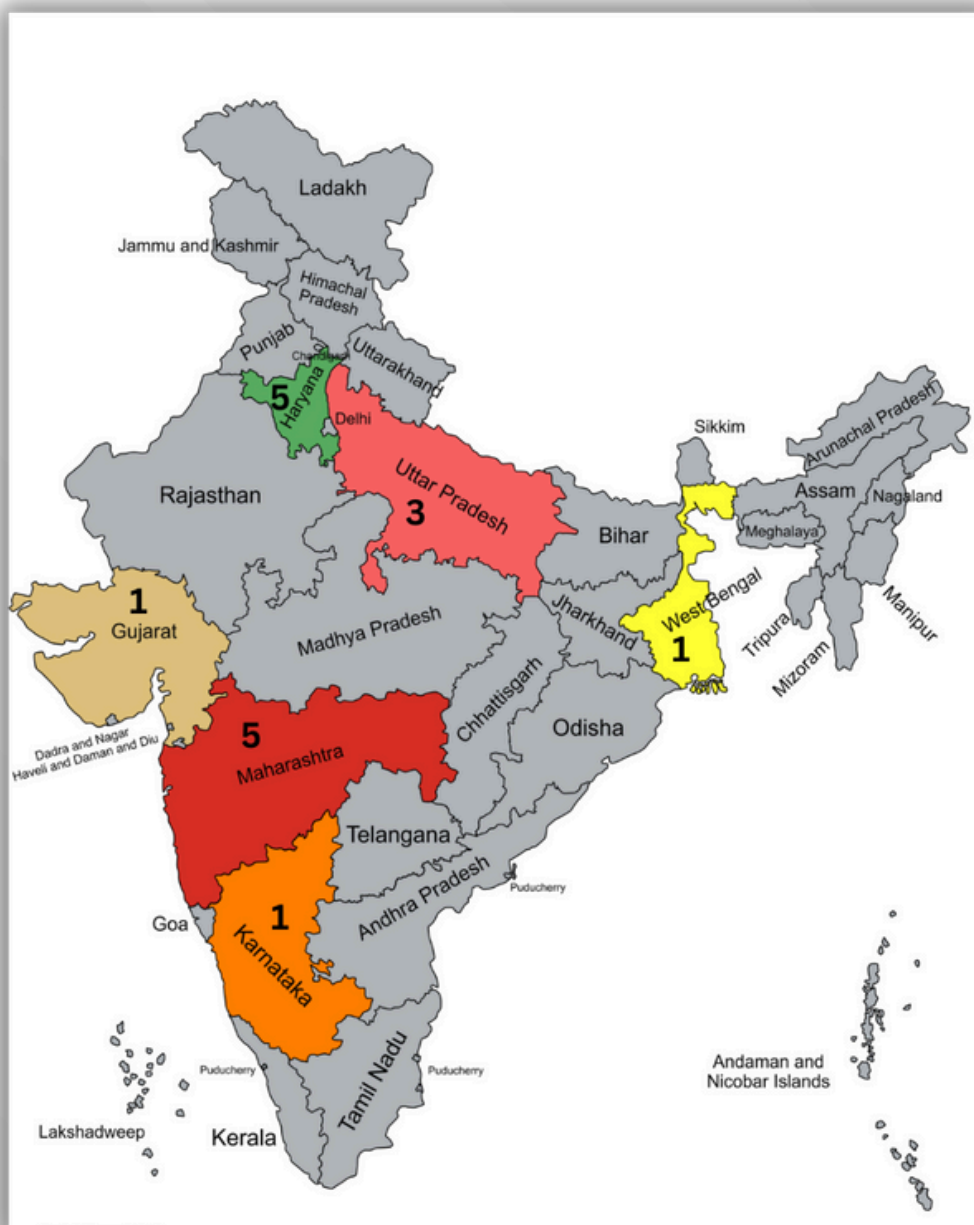
State-wise Accreditation of NABCB-Accredited Inspection Bodies

The map below displays the state-wise presence of NABCB-Accredited Validation and Verification Bodies (VVBs) across India.



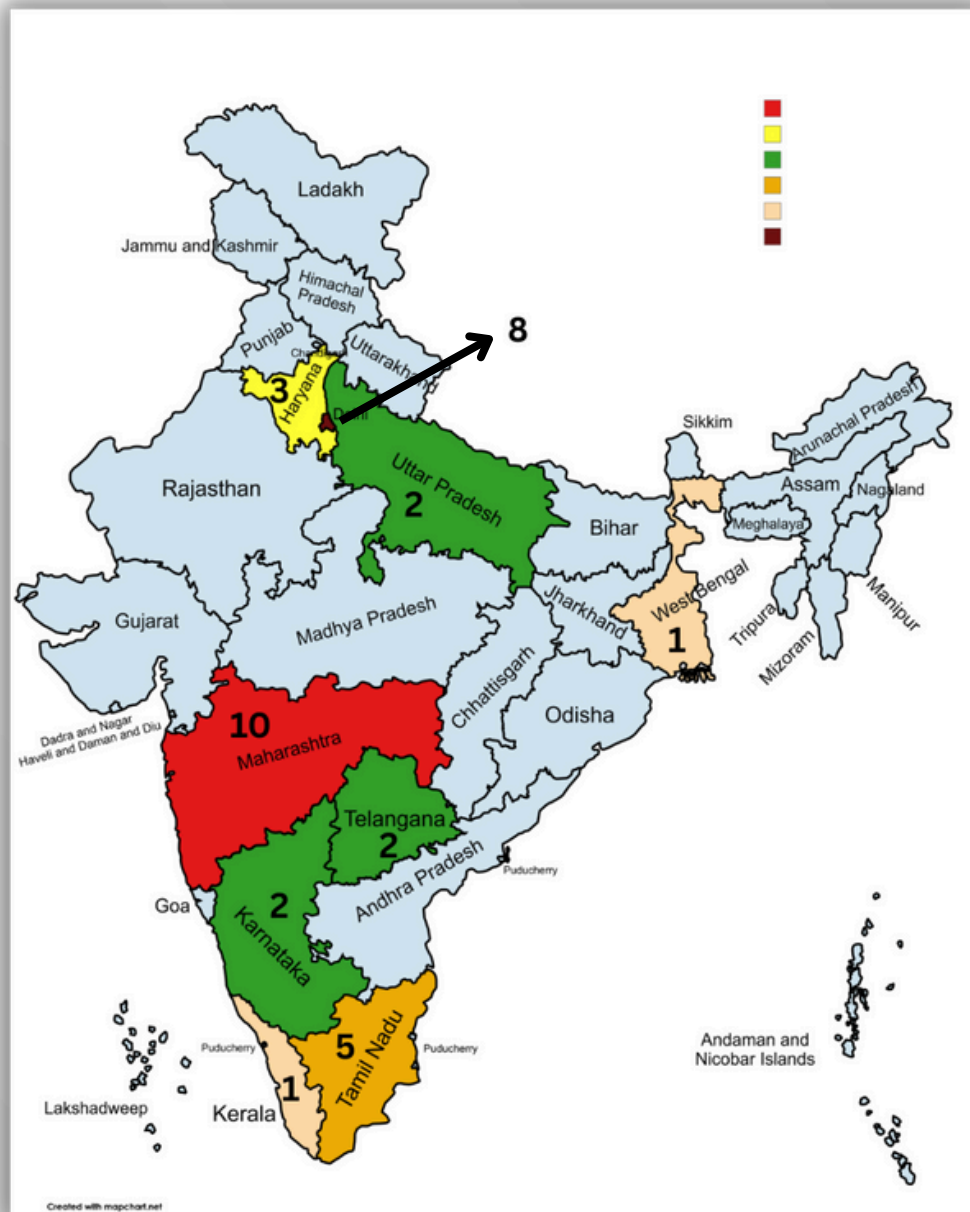
State-wise Accreditation of NABCB-Accredited Validation & Verification Bodies

The map below displays the state-wise presence of NABCB-Accredited Product Certifications Bodies (PCB) across India.

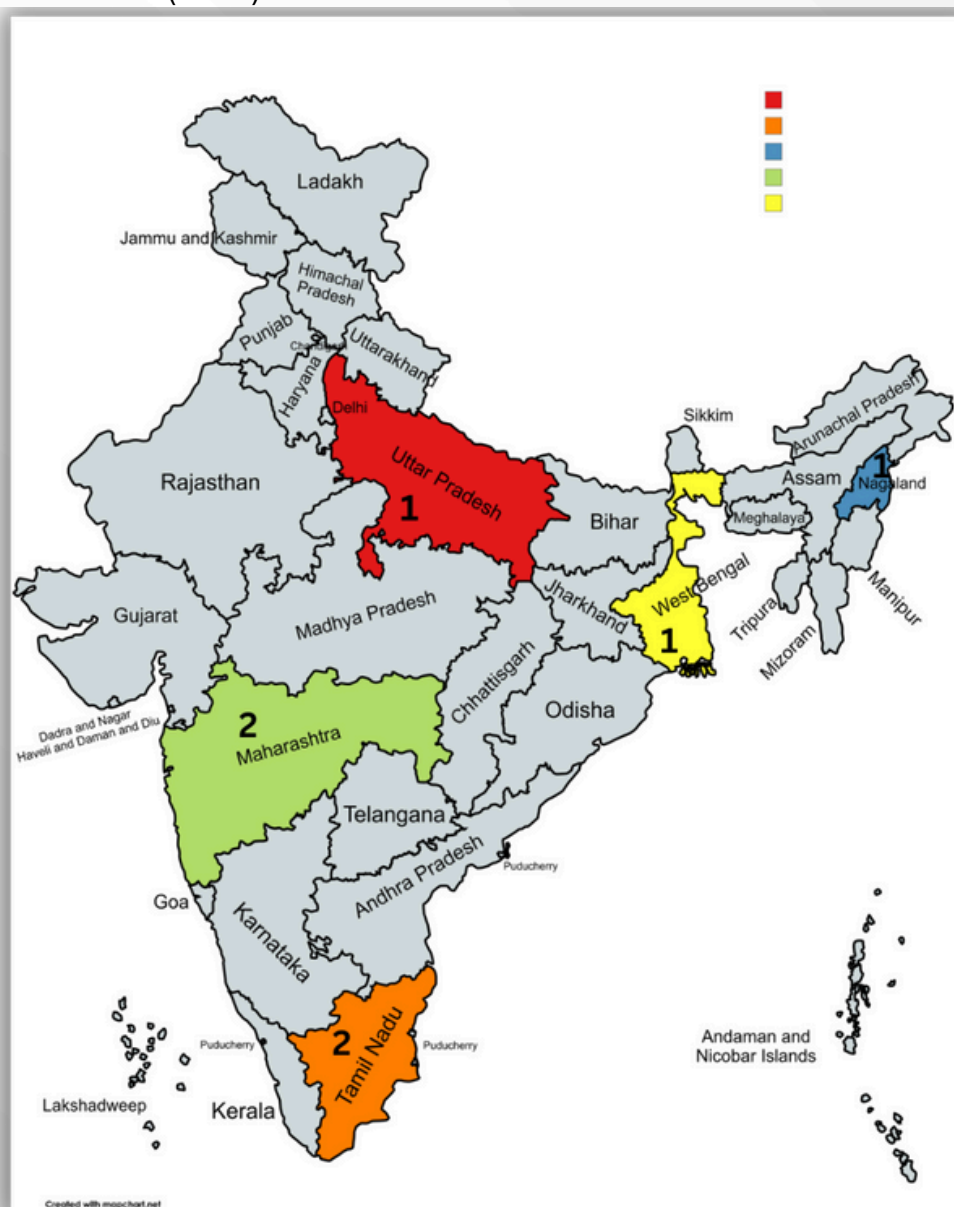


State-wise Accreditation of NABCB-Accredited Product Certifications Bodies (PCB)

# NABCB STARTED FSSC 24000 ACCREDITATION

## NABCB Commenced Accreditation for FSSC 24000



The National Accreditation Board for Certification Bodies (NABCB), under the Quality Council of India (QCI), has formally commenced accreditation for FSSC 24000, a globally recognized social sustainability and social management system certification scheme developed by the foundation FSSC. This marks a significant step in advancing responsible business practices and social accountability within Indian industries.

FSSC 24000 is based on PAS 24000:2022 – Social Management System Specification, which provides a structured framework for organizations to enhance their social performance. The scheme focuses on key aspects such as labor conditions, human rights, workplace well-being, and ethical business conduct—expanding beyond traditional food safety schemes like FSSC 22000 to address the broader dimensions of social sustainability.

With the introduction of this Accreditation, NABCB now empowers Certification Bodies (CBs) to audit and certify organizations against FSSC 24000 requirements. This development enables Indian companies to demonstrate compliance with internationally accepted social responsibility standards, enhancing their credibility, strengthening stakeholder trust, and improving their standing within global supply chains.

# ADVANCING INDIA'S CARBON MARKET

## NABCB's Role in Carbon Credit Trading Scheme (CCTS)

Bureau of Energy Efficiency (BEE) has formally notified the National Accreditation Board for Certification Bodies (NABCB) to provide accreditation services for the Carbon Credit Trading Scheme (CCTS) as the accreditation body for accreditation of Accredited Carbon Verification Agency (ACVA)/Validation Verification Bodies on 21st August 2025.

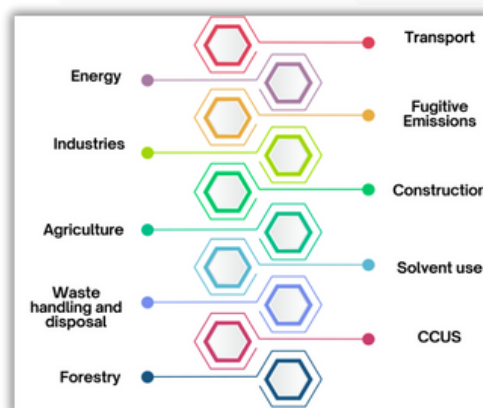
“Compliance Mechanism” means a mechanism under this scheme where the obligated entities shall comply the greenhouse gas emission norms as notified by Central Government

# NABCB GRANTED ACCREDITATION FOR ISCC CORSIA

## NABCB Grants First Accreditation under the ISCC CORSIA Scheme

The National Accreditation Board for Certification Bodies (NABCB) has achieved a significant milestone by granting its first accreditation under the International Sustainability and Carbon Certification (ISCC) CORSIA Scheme, developed for Sustainable Aviation Fuel (SAF). The ISCC CORSIA program, established under the Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA) of the International Civil Aviation Organization (ICAO), ensures that SAF complies with stringent international sustainability and lifecycle greenhouse gas emission standards.

By virtue of signing MOU with ISCC, NABCB is now among the few Accreditation bodies worldwide authorized to operate within the ISCC CORSIA scheme—strengthening India's leadership in sustainable aviation and enhancing the credibility of SAF production and supply chains. Indian Oil Corporation Ltd. (IOCL) became the first Indian entity to achieve ISCC CORSIA certification for SAF production at its Panipat Refinery under NABCB Accreditation. This milestone significantly advances India's capability to produce, certify, and commercialize sustainable aviation fuels, supporting global decarbonization goals and enabling cleaner, future-ready aviation.

# MONTHLY HIGHLIGHTS- ACCREDITATION & SUSTAINABILITY INITIATIVES

## Better Cotton Initiative (BCI) – Scheme Inclusion

By virtue of signing MOU with BCI, NABCB supports responsible and sustainable textile production through its Accreditation Services for the Better Cotton Initiative (BCI). The scheme focuses on improving Cotton farming practices by promoting reduced environmental impact, fair labor conditions, and enhanced supply chain traceability. Through Accreditation of Certification Bodies under NABCB for BCI Scheme enables credible verification of sustainable cotton practices and strengthens India's position in ethically sourced textile production.



## First Accreditation for the Global Organic Textile Standard (GOTS)

NABCB achieved a significant milestone by granting its first Accreditation under the Global Organic Textile Standard (GOTS) to Nimkartek Technical Services Pvt. Ltd., Thane, Mumbai -marking India's entry into independently Accredited GOTS-certification capability. GOTS is one of the world's most stringent and trusted standards for organic fiber processing, covering environmental criteria, chemical-input restrictions, wastewater management, social-responsibility compliance, and full supply-chain traceability.

Before any chemical substances can be used in the manufacturing of GOTS-certified goods, they must be assessed and approved by an Accredited Certifying Body. Nimkartek Technical Services Pvt. Ltd. who is authorized to evaluate compliance in accordance with the GOTS criteria for safe, sustainable chemical usage.
